



TERMS & CONDITIONS OF ENTRY

REFUSAL OF ENTRY: FOR THE COMFORT, SAFETY & ENJOYMENT OF ALL PATRONS, QSEC MANAGEMENT RESERVES THE RIGHT TO:

- REFUSE ENTRY TO ANY PERSONS DEEMED TO BE INTOXICATED AND/OR DISORDERLY REFUSE ENTRY TO ANY
- UNAUTHORISED PERSONS
- REFUSE ENTRY OF ITEMS WHICH HAVE THE POTENTIAL TO CAUSE INJURY OR PUBLIC NUISANCE

GENERAL CONDITIONS

- QSEC RESERVES THE RIGHT TO INSPECT/SEARCH BAGS OF ALL PERSONS WHO ENTER, HAVE ENTERED OR EXIT THE MAIN ARENA, REGARDLESS OF SIZE. THIS MAY INCLUDE THE TOUCHING OF THE OUTSIDE OF THE BAG AND/OR SEEKING ASSISTANCE OF THE BAG OWNER TO REMOVE ITEMS FROM THE BAG.
- PERSONS GAINING UNAUTHORISED ACCESS TO QSEC AND/OR THE VENUE'S MAIN ARENA PRECINCT MAY BE LIABLE FOR PROSECUTION.
- PATRONS WHO CAUSE A DISTURBANCE, OR REFUSE TO COMPLY WITH REQUESTS MADE BY QSEC STAFF AND VOLUNTEERS WILL BE EVICTED FROM QSEC.
- PASS OUTS WILL NOT BE ISSUED UNLESS AUTHORISED BY SECURITY AND/OR QSEC STAFF.
- ALCOHOLIC BEVERAGES CANNOT BE TAKEN INTO OR FROM QSEC BY PATRONS.
- SMOKING ON THE PREMISES IS ONLY PERMITTED IN DESIGNATED SMOKING AREAS AND NOT WITHIN SEATING, ENCLOSED OR FOOD/BEVERAGE SERVICE AREAS.
- CUSTOMERS WISHING TO BRING PERSONAL ITEMS INTO QSEC DO SO AT THEIR OWN RISK. QSEC WILL NOT BE HELD RESPONSIBLE FOR ANY DAMAGES TO, LOSS OR THEFT OF A PATRON'S PERSONAL PROPERTY.
- UMBRELLAS & CHAIRS MAY NOT BE BROUGHT INTO THE MAIN ARENA.
- UNAUTHORISED SOLICITING AND CUSTOMER SURVEYING IS NOT PERMITTED.
- PATRONS ARE NOT PERMITTED TO THROW OBJECTS AROUND OR WITHIN THE QSEC SEATING AREAS.
- PATRONS ACKNOWLEDGE THAT QSEC OR THE EVENT ORGANISER/PROMOTER MAY USE A PATRON'S IMAGE OR LIKENESS AS PART OF ANY RECORDING OF THE EVENT.
- PATRONS CAN BRING LIMITED OUTSIDE SNACKS AND UNOPENED, SEALED WATER BOTTLES INTO THE VENUE.

RESTRICTED / PROHIBITED ITEMS: THE FOLLOWING RESTRICTED/PROHIBITED ITEMS ARE NOT PERMITTED AT QSEC.

- GLASS
- CANS / BOTTLES / CONTAINERS INCLUDING GLASS, METAL OR ALUMINUM
- ALCOHOL
- ILLICIT OR ILLEGAL SUBSTANCES
- FLARES/FIREWORKS
- KNIVES OR OTHER ITEMS CONSIDERED AS WEAPONS
- COMMERCIAL CAMERAS AND RECORDING DEVICES
- HELIUM BALLOONS
- OVERSIZED BANNERS & FLAGS
- WHISTLES, HOOTERS, HORNS, MUSICAL INSTRUMENTS
- CONFETTI OR SHREDDED PAPER
- SCOOTERS, ROLLER SKATES, SKATEBOARDS, PUSH BIKES
- ESKIES OR HARD CASE COOLERS
- UMBRELLAS
- SELFIE STICKS, MONOPODS, TRIPODS
- OTHER ITEMS AS DETERMINED BY QSEC STAFF THAT MAY CAUSE INJURY OR PUBLIC NUISANCE.

LIQUOR LICENSING: ALL PERSONS ENTERING QSEC ARE ADVISED THAT:

- THEY ARE ENTERING A LICENSED PREMISES
- INTOXICATED PERSONS ARE NOT PERMITTED TO ENTER
- PERSONS IN POSSESSION OF LIQUOR ARE NOT PERMITTED TO ENTER
- CHECKING PROCEDURES WILL APPLY TO PREVENT PERSONS WHO POSSESS LIQUOR FROM ENTERING
- INTOXICATED PERSONS WILL BE REMOVED FROM THE PREMISES
- PERSONS FOUND TO BE IN POSSESSION OF UNAUTHORISED LIQUOR WILL HAVE THE ITEMS CONFISCATED AND NOT RETURNED IT IS AN
- OFFENCE FOR MINORS TO PURCHASE AND/OR CONSUME LIQUOR
- IT IS AN OFFENCE TO PURCHASE LIQUOR FOR (OR SUPPLY LIQUOR TO) MINORS
- PERSONS SUPPLYING LIQUOR TO MINORS WILL BE REPORTED TO POLICE AND PENALTIES APPLY UNDER THE LIQUOR ACT 1992. QSEC SUPPORTS THE RESPONSIBLE SERVICE OF ALCOHOL

DRESS STANDARDS: AS A MINIMUM FOR GENERAL ADMISSION, PATRONS MUST BE APPROPRIATELY CLOTHED FOR A PUBLIC PLACE AND MUST WEAR SHOES. PATRONS WITH BARE FEET WILL NOT BE PERMITTED ENTRY.
