

## QSEC TERMS AND CONDITIONS OF ENTRY



**Refusal of Entry** - For the comfort, safety and enjoyment of all patrons, QSEC Management reserves the right to:

- Refuse entry to any persons deemed to be intoxicated and / or disorderly;
- Refuse entry to any unauthorised persons;
- Refuse entry of items which have the potential to cause injury or public nuisance (i.e. large flags / banners, musical instruments, helium balloons etc).

### General Conditions

- QSEC reserves the right to inspect / search bags of all persons who enter or exit the Main Arena, regardless of size. This may include the touching of the outside of the bag and / or seeking assistance of the bag owner to remove items from the bag.
- Persons gaining unauthorised access to QSEC and / or the venue's Main Arena may be liable for prosecution.
- Patrons who cause a disturbance, or refuse to comply with requests made by QSEC staff and volunteers will be evicted from QSEC.
- Pass-outs will be determined by QSEC Management.
- Alcoholic beverages cannot be taken into or from QSEC by patrons.
- Smoking on the premises is only permitted in designated smoking areas and not within seating or enclosed areas.
- Customers wishing to bring personal items into QSEC do so at their own risk. QSEC will not be held responsible for any damages to, loss or theft of a patron's personal property.
- Umbrellas and chairs may NOT be brought into the Main Arena.
- Unauthorised soliciting and customer surveying is not permitted.
- Customers are not permitted to throw any objects around or within the QSEC seating areas.
- Patrons acknowledge that QSEC or the event promoter may use a Patron's image or likeness as part of any recording of the event.
- You can bring limited outside snacks and sealed water bottles to QSEC. The following will NOT be permitted: metal (cutlery etc); alcohol; thermos flasks; hot food/drink; large coolers/eskies/picnic baskets; or any form of glass (bottles, containers etc). Cushions are permitted.

**Restricted / Prohibited Items** - The following restricted / prohibited items are not permitted at QSEC:

- Glass or cans;
- Alcoholic beverages;
- Flares/Fireworks;
- Laser pointers;
- Knives or other dangerous weapons;
- Cameras and recording devices (for commercial purposes) including tripods; detachable lenses.
- Helium balloons;
- Oversized banners and flags which are deemed to cause public nuisance.
- Whistles, hooters and horns, musical instruments;
- Confetti or shredded paper;
- Scooters, roller skates, skateboards and push bikes;
- Clothing or otherwise displaying commercial, political or other offensive signage or logos;
- Eskies;
- Umbrellas;
- Selfie Sticks
- Other items as determined by QSEC management that may cause injury or public nuisance.

**Please note that the above Conditions of Entry may vary between events.**

**Liquor Licensing** - All persons entering QSEC are advised that:

- They are entering licensed premises;
- Intoxicated persons will not be permitted to enter;
- Persons in possession of liquor will not be permitted to enter;
- Checking procedures will apply to prevent persons possessing liquor from entering;
- Intoxicated persons will be removed from the premises;
- It is an offence for minors to purchase and consume liquor;
- It is an offence to purchase liquor for (or supply liquor to) minors;
- Persons supplying liquor to minors will be reported to the Police and penalties apply under the Liquor Act 2007.

### Responsible Service of Alcohol

QSEC supports the responsible service of alcohol.

### Dress Standards

- As a minimum for general admission, patrons must be appropriately clothed for a public place and must wear shoes. Patrons with bare feet will not be permitted entry.
